Item 1. Program Goals and Objectives

The Fire Fighter I Academy Certificate of Achievement is designed to meet the training and educational requirements established by the State Fire Marshal's Office for Fire Fighter I certification. The program will prepare students for the national registry exam and certification as a California State Emergency Medical Technician. After successful completion of this certificate, students will be authorized to take the National Registry EMT examination.

Upon completion of the following courses with a grade of 'C' or better in each course, students will be awarded a Fire Fighter I Academy Certificate of Achievement. Career Subject Area: Firefighting Career Opportunities: Fire Service

Item 4. Master Planning

There is currently no Fire Fighter I certificate at Bakersfield College. The program is designed to prepare students in a timely manner for entry-level positions in the fire service fields.



Item 6. Place of Program in Curriculum/Similar Programs

Students who complete our current academy course are issued a certificate through the State Fire Marshal. This program will allow Bakersfield College to issue a certificate, and receive recognition for providing the training. Students who complete this academy will receive both the certificate of achievement from Bakersfield College and the State Fire Marshal certificate.

Item 7. Similar Programs at Other Colleges in Service Area

Bakersfield College was the first to offer a Fire Fighter I Academy, and the only academy in the Kern Community College District service area for many years. Porterville College currently offers this program. While they are part of our district, they service a different county.

Student Education Plan (SEP) Pathway

Goal: develop a pattern of courses including both major and general education courses for college-ready students earning their degree in 2 years.

Pathway Guidelines:

- 1. Create a pattern of course-taking for a full-time student (12-16 units per semester=60 units total).
- 2. Start the pathway at college level. Academic Development will create a pathway for underprepared students.
- 3. Research demonstrates that students who complete their English and Math first are more successful.
- 4. Be sure the order of the coursework includes prerequisites taken at appropriate times.
- 5. Consider a balance between major courses, general education courses and easy versus hard courses.

1. Review and vote to accept the minutes of the previous meeting.

A vote was taken and passed unanimously to accept the minutes of the last meeting.

2. Go over the budgets. Both ODFT budgets were provided and reviewed; Janet asked if we could cc her when Karen generates future purchase orders.

3. Should Blake Abbot receive his F/F I Academy certificate?

In an effort to meet this college need the advisory board agreed and voted to approve the following certificates: F/F I academy, EMT, and Wildland F/F (vote passed unanimously).

8. Discuss purchase of new turnouts for student F/F 1 academy.

The purchase of new turnouts for the student firefighter I academy was discussed. Chief Ballard brought up that the turnout life per NFPA standard was ten years. Some of our turnouts are quickly nearing expiration. A vote was taken and It was agreed upon to replace the turnouts. I obtained a price quote from LN Curtis to replace them at a cost of \$70,000. I will work on two more quotes and bring back to the board for a decision on which vender we will go with and a final cost.
