### Regional Highlights

## Regional Project Success Story: Precision Agriculture Curriculum and Pathway Development

Following-up to a pilot convening held in June 2018 and in response to a request from community college faculty for more pathway specific professional development in the Agricultural Sector, in August 2019, a 2-day convening for pathway specific professional development in Precision Agriculture and Curriculum development was held that involved working with industry representatives. Ag faculty from around the region came together with industry to collaborate and to respond to the need to maintain pathway consistency with industry trends and changes. The faculty collaborated to develop an outline of what the pathway could look like, including additional certificates and concentrations. An opportunity to identify solutions to address the difficulty for small programs and having getting enough students enrolled to get the classes offered by the colleges was highlighted to research the possibility of sharing FTEs among small or growing programs. The development of this pathway is ongoing and will continue through the 2019-2020 Fiscal year.



Ag, Water and Environmental Technologies (AWET) Regional Director Krista Vannest and regional project lead for the CRC Region Wide SWP project Precision Agriculture Curriculum and Pathway Development shared, "Community college faculty were recognizing the trends in industry with regards to emerging Precision Agriculture training. Independently these faculty were attempting to develop curriculum and/or pathways with varied results. Many faculty and program administrators were unaware of other colleges within the region and state that were working towards the same goals." The convening provided the outlet for the development of best practices and sharing resources. These efforts, leveraged with the involvement of the AWET State Director Nancy Gutierrez are important to supporting one of our region's priority industry sectors. Twelve of our 14 regional colleges offer AWET related program pathways.
