4. Strong Workforce Program – SW1 Project Updates (Steering Committee/Project Leads) – fiscal progress
  - Status of SW1 Program Progress
    - a) Invoicing - **should be done quarterly at a minimum; current invoicing is way behind for the region districts; reporting spending on NOVA is not the same as submitting invoices to the fiscal agent (SCCCD);**
    - b) SW1 Reallocation Planning (**SW1 funds should be spent by 12/31/18); reallocation of funding within a district can be done without re-approval because it was already approved for the district; can reallocate local funds to regional funds but not the other way (not from regional to local);**

continuation) Discussion: This is not the CRC Region Wide marketing program with a similar name

  - a) Project Detail - Karri has gone through and there is still more work to be done; SC found Karri's feedback helpful;
- SWP Program Year 2 & Year 3 Funds (SW2/SW3) & 17% Update - Notes: FIFO was approved; end of December we need to be able to show that we have spent all of SW1; working out kinks of how to report FIFO over multiple years; spending on SW1 will cease on 12/31/18; by 4/27/18 let Karri know if you will be able to expand an existing project or propose a new regional project; will need to submit how you will be reallocating funds that won't be spent by 12/31/18 deadline;

7. Chair Updates (Hammerstrom) -
  - CRC Annual Conference - Notes:
  - Other - Notes: K12 SWP - talked a little about the K12 Strong Workforce Program; Chancellor's office is pretty sure this will go through the community college system due to the past successes of the SW1 funded programs; will not be sector specific; possibly have a subcommittee for the K12 SWP that would include K12 partners; how do we include industry; LEA would apply to regional consortia for funding - reporting questions - they don't want to overload the system and drag down the existing SWP system; oversight in the form of one per district vs one per region being discussed; this takes the place of the SB1070 funds that are going away.
  - ISPIC - colleges should be in communication with the SN/DSNs about their ISPIC projects;
  - DSN RFA - should be out by end of week; single fiscal agent for all 56 DSNs; composition has changed for some regions to better fit the needs of the region; our region will have a longer more methodical process for this; CO will be releasing mini-grants to have DSNs in place by September 2018; CO is paying for July and August extension on DSNs to cover the interim; composition of RFAs will change due to needs change and retirement; CO may call for regional review for region; SN will also be reviewed by the RCs too;
8. CCCCCO Update - Notes: Jean-Claude spoke - two districts haven't certified Perkins reports; need invoices for SB1070 asap - please do not wait to submit; he will get us the names of the districts that haven't certified; Strong Workforce monitors? No new updates at this time.
9. Center of Excellence (Nora Seronello) - Notes: Nora not able to attend; Karri asked for questions; Tony Cordova gave his thanks for the work she has done.
10. TPP - Kris Costa gave an update on TPP; looking to hire a coordinator for the region TPP; Tony Cordova states that there will be an event from 4:30-7:30pm on 3/20/18 at Bakersfield College doing a TPP Kick-off with students - other colleges invited to attend to see how they are doing a kick-off;
11. DSN & TAP Updates (*see written reports*) - Notes: [Dave Teasdale](#) - small bucket of Prop 39 funding available end of April - beginning of May (top codes available are on his report); OSHA class being held (possible surveymonkey to find out what dates would work for the region); Karri proposed a new lineman program at one of our regional colleges; [Gurminder Sangha](#) - 5/17 Manufacturing Summit in Fresno; South SJV Summit being planned; Ind Automation Collaborative - sent out crosswalks and received from FCC - good meeting with faculty; 4/20 Faculty convening (passed out agenda); 9/17 at FCC - looking for another college to host in October 2018 and November 2018 - looking for volunteers; proposing a Tour of Optec Center in Fontana (if approved by SC) - also possible tour of Rockwell Center to see where they are doing their training - also train-the-trainer at Rockwell; Irvine Valley College has a laser program (proposing as a possible new program) - Livermore willing to help; "National Skill Standards for Photonics Systems

Technicians” packet handed out by G. Also gave information out on AWS Online Educational Library (American Welding Society); “Project Charter: Advanced Manufacturing Collaborative for CRC” - packet given out; Valerie Fisher - focusing on soft skills for allied health nurse faculty - first one this Friday 3/9, next one is 3/23 at Clovis Herndon Campus, next one 4/20 and needs a location in the south valley (volunteer college needed); book has been printed 10K and 7K already distributed all over the state; now downloadable off of the website (HWI website) - FUSD has ordered 800 copies; Bonita Steele - workshops are being put together for GFSF and career exploration and implementation - will be sending out a list of the events; money left to support alignment and transitions and looking for proposals; Krista Vannest - met with Nancy Guttierrez and other Ag DSNs - doing educating for careers event; working on some tours (World Ag Expo with 50 counselors took tour); working on tour for Delta College - student tour of industry related to Ag to help their program grow; next to Occupational Olympics at Columbia College; Agritourism tour which combines all 5 sectors; Career Fair at MJC and meeting next week for follow-up and planning for next year’s event; still trying to get around to all of the colleges and to the high school ag instructors; summer meeting for ag departments being organized; mid winter retreat is in Humboldt county and looking to charter a bus and doing the meeting (December 2018) on the bus and looking to have all the Ag faculty to come to the meeting (also looking at marijuana industry/growth while there); working with Ag Guided Pathways (David Clark); big livestock jackpot show (Pacific Showcase magazine - Krista will be writing an article) talking about animal ag careers marketing; deans at Fresno State discussions and email will be sent out soon about convening - possibly meet in December; Dennis Mohle - 4/13/18 tech fest at COS high school cyberpatriot outreach/competition; mayor’s cup hosted by Dinuba High School - cyber patriot teams to advance on 4/28 in Dinuba; third party vouchers - 100 vouchers available; Lori Morton -
