D colleges no and annour The following	Tony Cordova, Vice Chancellor of Workforce Development, California Community Colleges, shared the following slide deck presentation. Tony emphasized that there is great importance behind the work that the consortium is doing, which is having a significant impact on students. He then proceeded to show the Start Your Cybersecurity Career at a California Community College video. Tony is asking for success stories to showcase the achievements of the CVML Region. He is also working on creating a newsletter. Don Daves-Rougeaux, Senior Advisor to the Chancellor, stated that they have been asked to share success stories, and they would like to have a variety from different colleges in the region. Tony aims to enhance the visibility of each consortium's work and the Center of Excellence. This is to focus on the people aspect when addressing the question "How will we advance the work?" Tony shared that the Governor's Master Plan on Career Education will be out in October 2024. Don encouraged the colleges to bring up the challenges and ideas to them, in order to, if it makes sense, launch it. There is no idea off the table. Don encourages everyone to read the Governor's Career Education Executive Order. Tony shared that colleges not meeting project targets will face funding cuts for lack of progress. Tony shared that the policy updates and announcements can be found on the California Community Colleges Chancellor's Office website. The following conversation ensued: David Clark requested that the Chancellor's office provide this data annually. It's important to have access to the data that supports our work. David emphasized the importance of being mindful of the wording in the Ag Tech Project. It states that once the workers are trained, they can pursue different job opportunities. However, our goal						



		is for the employers to retain their workers and to elevate the skills of their agricultural workforce.	
		Becky Barabe emphasized the importance of partnering with Adult Education when reaching out to adult students. In many cases, there is also a language barrier.	
		Jonna Schengel shared that they will be partnering with Adult Education and will be providing Career Technical Courses to those students.
